## TERMS AND CONDITIONS

Applications are processed on a first come basis. Once our team spots are filled up, remaining applications will be put on a waiting list. If a spot becomes available, we will fill them from the waiting list in the order they were received. Once your application has been approved you must register with NYRR before September 4, 2020 in order to secure your guaranteed entry.

**FUNDRAISING COMMITMENT:** A fundraising minimum of \$2,500 is required as a member of the Roads to Success Marathon Team and to receive an invitational entry for the 2020 TCS New York City Marathon on November 1, 2020. If you are accepted onto the team, a non-refundable deposit of \$25 will be charged to your credit card.

A valid credit card (MasterCard, Visa or Amex), in your name and valid through October 2020, must be provided upon acceptance to the Roads to Success Team. On October 23, 2020, the fundraising minimum of \$2,500 will be due. On October 23, 2020, your credit card on file will be billed for any balance due to reach the fundraising minimum of \$2,500. If you do not meet the fundraising requirement for any reason, your status will be marked as “removed” from the team and you will be ineligible for guaranteed entry to the 2021 TCS New York City Marathon.

**CANCELLATION POLICY:** You may cancel your participation with the Roads to Success Marathon Team for the 2020 TCS New York City Marathon, waiving your responsibility for the \$2,500 minimum, any time on or before August 10, 2020. You must contact the Roads to Success Development office, on or before the cancellation date. Your \$25 deposit is non-refundable and a cancellation fee of \$75 will be charged. Donations raised and received by our office will not be refunded, even if you cancel before August 10, 2020. After August 10, 2020, you are responsible for raising the \$2,500 minimum, even if for any reason, including injury, you are unable to participate in the marathon. If you fulfill the fundraising minimum but are unable to participate for any reason, including injury, your status will be marked as “canceled” and you will be eligible for guaranteed entry for the 2021 TCS New York City Marathon. However, it will be your responsibility to register during the drawing application period and pay the standard registration fee for that race.

**MATCHING GIFT POLICY:** Many companies match employees' charitable contributions. You can check with your employer to see if your company has this program and ask your donors if their employers match gifts. Many companies issue matching gift checks quarterly or semi-annually, therefore, it is your responsibility to contact the matching company to ensure the check will be issued before October 23, 2020. If the company's match cycle is past October 23, 2020, the donation may not count toward your minimum.

**2020 TCS NEW YORK CITY MARATHON REGISTRATION:** Roads to Success will inform you of the details of how to receive your official race number after the Roads to Success Marathon Team application is accepted. You will have no registration fees associated with your registration for the 2020 TCS New York City Marathon.

**RELEASE FORM AND CONTRIBUTION AGREEMENT:**

In consideration of my accepting this entry, I hereby for myself, my heirs, executors and administrators, waive and release any and all rights and claims for any and all damages I may have against Roads to Success and sponsors for and including but not limited for any and all injuries, medical expenses, lost wages, property damage and consequential damages, suffered by me in said event and related activities (i.e. practice runs) resulting from the negligence or fault of Roads to Success and sponsors to the extent allowed by law. I further attest and certify that I am physically fit and have sufficiently trained for this event, and a licensed medical doctor has verified my physical condition. I also grant permission for use of my name and/or photograph or voice in broadcast, telecast, print or any other account of this event. I agree to collect the fundraising minimum of \$2,500 for Roads to Success by October 23, 2020. If I have not reached the minimum of \$2,500 in sponsorships by that date, I will be personally responsible for the balance owed. I understand that unless I cancel by August 10, 2020, Roads to Success reserves the right to charge the balance I owe to my credit card on October 23, 2020. If my credit card is no longer valid, I am responsible for securing an alternative form of payment, i.e. check or cash by October 23, 2020 in order to participate in the 2020 TCS New York City Marathon.
